

COMUNICADO A LAS MUNICIPALIDADES DEL PAÍS

El Ministerio de Finanzas Públicas con base en lo establecido en los artículos del 118 al 122 del Código Municipal, Decreto número 12-2002 y sus reformas contenidas en el Decreto número 22-2010, ambos del Congreso de República; y al cálculo matemático aprobado por la comisión específica para el año 2016, informa que el 14 de octubre de 2016 se hará efectivo a las municipalidades del país, el Aporte Constitucional, IVA-PAZ, Impuesto de Circulación de Vehículos y Distribución de Petróleo, correspondiente a la recaudación del mes de **septiembre** de 2016.
